2. Placenta Life provide placenta services including placenta encapsulation, placenta tinctures, placenta prints & Cord Keepsakes Placenta Life have been trained and certified by The Association Of Placenta Preparations Arts (APPA) an accredited training provider.
3. Placenta encapsulation itself is experimental in nature and whilst the benefits of consuming the placenta post birth are based on research studies, articles and testimonials from new mothers this research is ongoing and Placenta Life does not give any warranty or representation that these benefits are guaranteed.
4. Clients who choose to utilise these services take full responsibility of their own health and for researching and using the remedies provided in this service.

10. The Specialist retains ownership of any photographs taken of the Client's placenta which may be used anonymously for educations, advertising and promotional purposes. The Client will inform the Specialist if she does not wish photos to be taken of her placenta.
11. Placenta Life aims to prepare the placenta within 3 days after the birth. However we will not be held accountable should circumstance arise where the placenta encapsulation cannot be completed until an agreed date and time.
12. The Client agrees to store her placenta in the Transport Kit provided and agrees to ensure her placenta remains chilled until collection.
13. The Client agrees to contact Placenta Life within 12 hours after birth to arrange safe collection of her placenta and/or home visit.
14. The Client consents to the removal of the placenta from the hospital(or home) by the Specialist to the extent necessary for the performance by the Specialist of the placenta services.
